PLEASE NOTE

FEE SCHEDULE

All costs to operate SELP are paid by borrowers. Tax dollars are not used. You can expect to pay the following:

- Loan requests up to \$100,000 have a reduced and streamlined fee matrix:

- *Application Fee*: One tenth of one percent of the amount applied for (maximum fee \$2500) must be submitted with application. This fee may not be refunded.
- *Underwriting Fee*: \$500 or one-half of one percent of the loan request, whichever is greater, not to exceed \$5,000 must accompany the application.
- *Loan Fee*: One percent of the loan amount required at loan closing for all loans. This cost may be included in your loan.
- *Other charges*: Complex loans may have additional expenses, including, but not limited to, construction advances or legal review.

IMPORTANT—READ CAREFULLY

APPLICANT CERTIFIES AS FOLLOWS: We will use Small Scale Energy Loan Program (SELP) funds only to construct the energy project described. We will comply with all applicable rules and laws intended to preserve or enhance environmental quality. We will obtain all applicable local, state, and federal permits, approvals and licenses and comply with their terms and conditions. The undersigned is duly authorized to request this loan on behalf of the Applicant. Applicant declares under penalty of law that all facts given and information attached are true and correct. Applicant authorizes SELP to verify information necessary for loan analysis.
